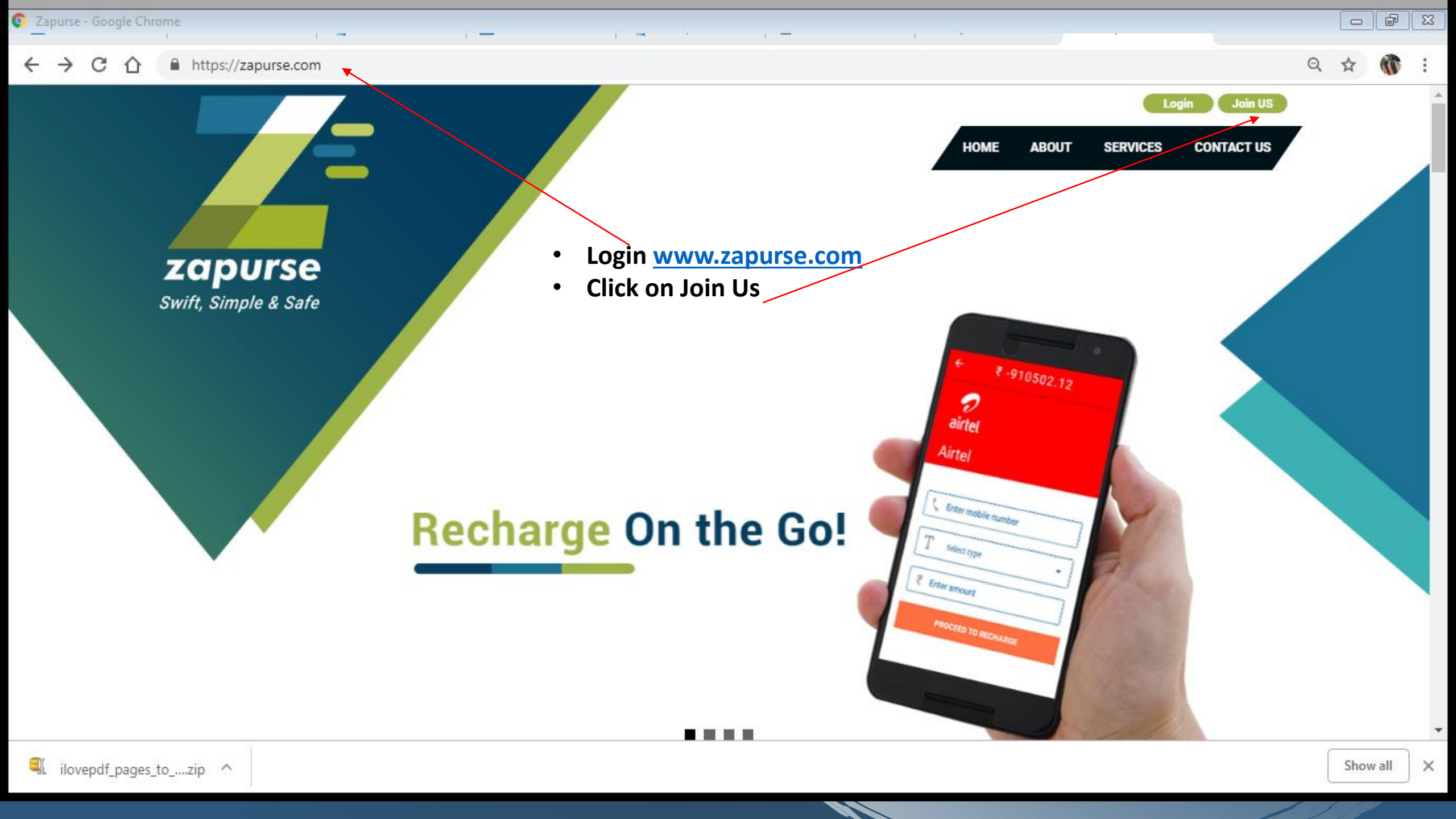

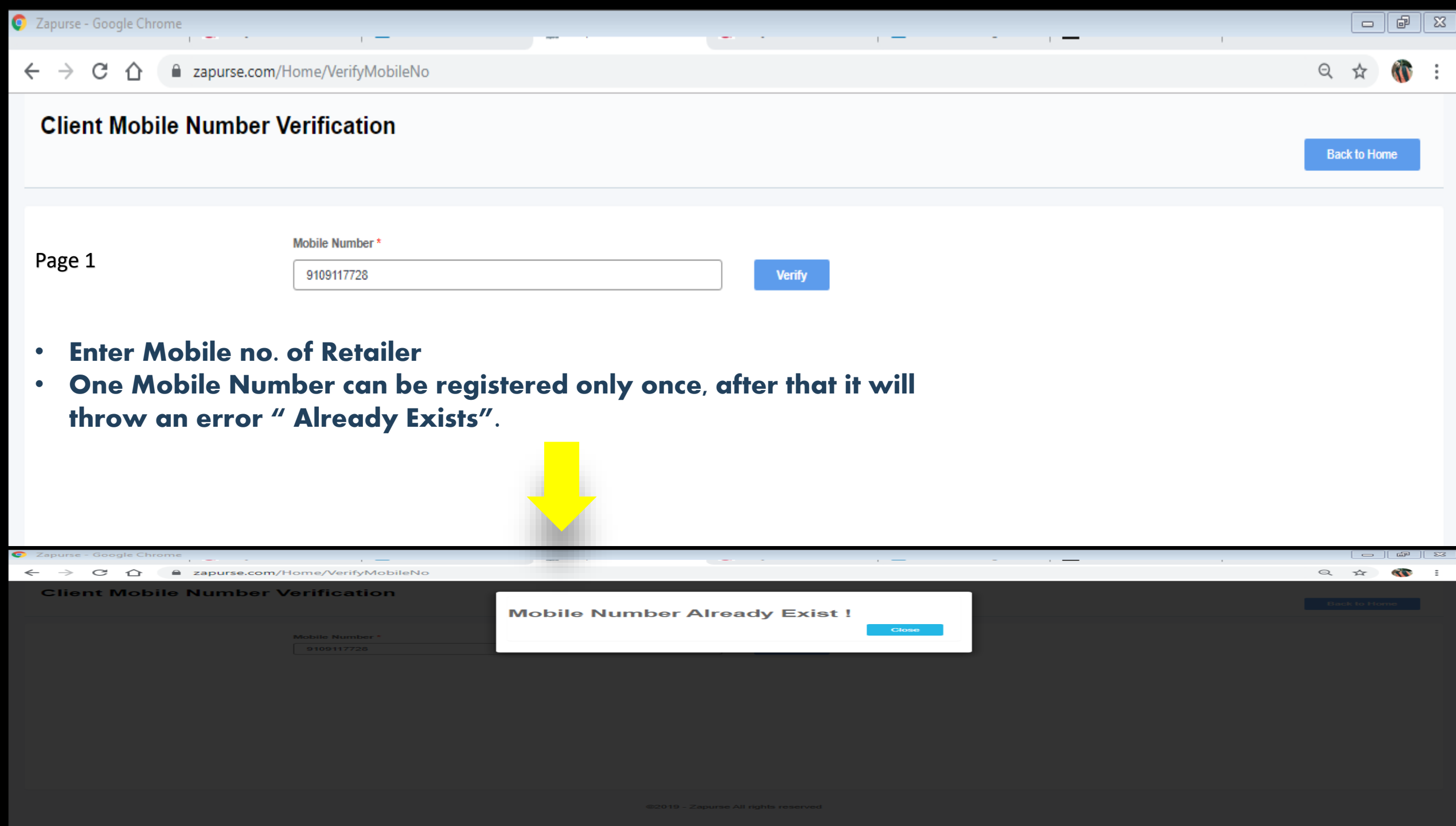

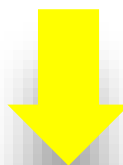

Zapurse Registration

- After submission of record, it will take 24-48 working hours to get the decision on registration.
- **If Rejected**, Retailer will get an **SMS and Email** with **rejection message**. Also, Retailer get an **email with a link**. By clicking on the link, Retailer routed to the rejection page, where he can correct the rejection and resubmitted the same.
- If OK, Retailer will get SMS and Email on registered Email and Phone no. with user ID and Password.

Post Activation/After ID approval

- After Activation , Retailer has to refill its account/portal by sending Online Money to Zapurse Bank Account.
- Account numbers and IFSC code are there in the portal.
- After sending money ONLINE, Retailer has to send Payment advise or detail of Payment to Zapurse team via Portal, so that Zapurse team can verify the transaction and load the money to the Portal
- When money reflects, Retailer can use the Money for Domestic Money Transfer, Recharge, Bill Payment, Indo-Nepal Money Transfer.

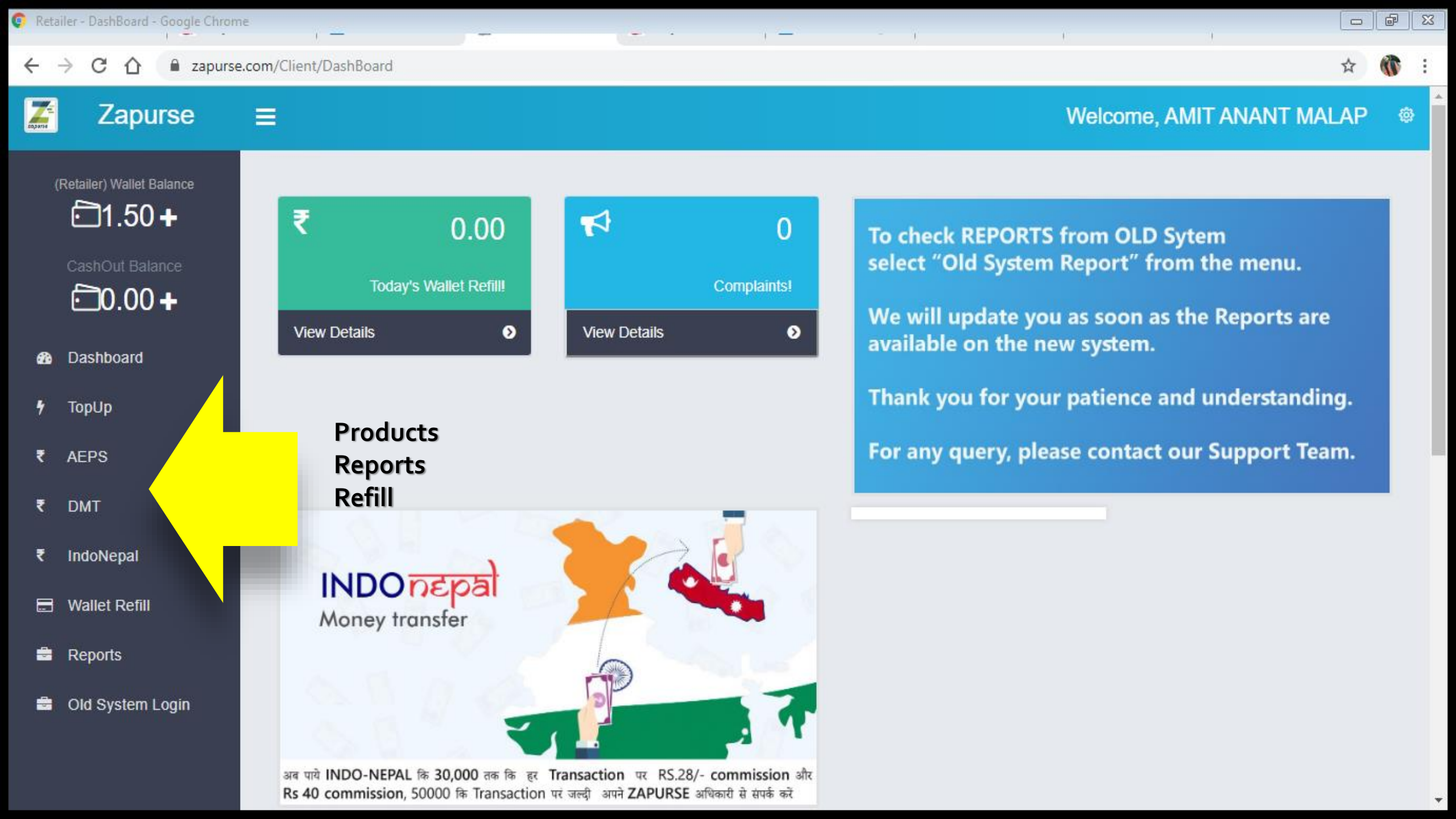
